BE IT ORDAINED by the Board of Commissioners of the Town of Warsaw:

Section 1. General Fund Expenditures:

The following amounts are hereby appropriated for operation of the Town of Warsaw General Fund to be accounted for utilizing the chart-of-accounts as provided for in the NC Local Government Accounting Procedures and implemented by the Town of Warsaw, for the year beginning July 1, 2020 and ending June 30, 2021.

Section 11. Taxes Levied:

There is hereby levied a tax rate of \$0.55 per \$100.00 valuation for the purpose of raising the revenue from current year's property tax for taxable property as listed for taxing purposes as of January 1, 2020. Such rates are based on an estimated total valuation of property for the purposes of taxation of an estimated \$216,804,000.00 (100% valuation) with anticipated collection rate of 96.70%.

Section 12. Capitalization:

For the purpose of tracking capital items, there shall be a threshold of \$5,000.

Section 13. Distribution:

Copies of this ordinance shall be furnished to the Finance Officer and the Budget Officer of the Town of Warsaw to be kept on file by them for their direction in the disbursement of funds.
